We understand that home time for some owner operators is just as important as revenue. We do our best to get our contractors home on the weekends, if so desired. We do ask for flexibility, however, to stay out 7-10 days at a time, when necessary. Different areas vary in frequency of frieght in and out. For most contractors, giving it some time to see how long you need to be away from home to make the amount of money you are happy with is what works best. Home time is totally up to you, but that must be balanced with making a living.

Insurance and Safety

Qualifications & Guidelines

- Class A CDL issued by State of legal residence reflecting current address and have information on any other licenses held within prior 5 years.
- Valid DOT long form physical card dated within the last 12 months (6 months if subject to yearly re-certification), this must be reflected on MVR.
- Submit a complete DOT compliant application including 10 yrs of employment history details. Any falsification of the application may result in immediate termination of contract.
- Minimum of 2 yrs recent verifiable all season tractor trailer experience in an overthe-road setting.
- No alcohol or substance related charges or convictions within 5 yrs immediately prior to date of application and no record of multiple convictions, regardless of time frame.
- No felony convictions or pending charges within the prior 5 years involving charges of theft or violence and no record of multiple convictions.
- No DOT recordable crashes deemed preventable within the 18 months prior to application and no more than 3 non-DOT preventable crashes/incidents within the prior 5 yrs.
- No more than 2 moving violations within the prior 24 months and no more than 4 moving violations within the prior 5 yrs, this will include violations recorded on both MVR and DOT PSP report.
- No major operating violations within the prior 24 mos.
- Must possess the ability to effectively communicate in verbal and written English.
- Must comply with all requirements for alcohol and substance testing under section 382 FMCSR.
- Trucks must be 14 yrs or newer.
- Driver must be 23 yrs of age or older.

All candidates will be screened vis FMCS-PSP report and MVR from states of licensing to reach a determination of over0all safety fitness. PSP violations, even in the absences of civil citations, may be determined to disqualify the candidate from being offered a contract.

Circle Transportation, Inc. can provide some of this equipment and deduct the cost from the contractor's 1st settlement, depending on availability, Contractor must be prepared to provide their own equipment when it is not available for purchase through the company. Mobile printers are not provided by the company at any time.

Orientation

Orientation is held in Fort Wayne, IN. Drivers will be required to bobtail to Fort Waye and the truck will be inspected there in the shop that we approve. If the truck passes the 1st inspection, Circle will pay for it. If the truck does not pass the 1st inspection, we will not pay for the inspection and we will not pay for any repairs. The Driver is welcome to take the truck anywhere he/she chooses if repairs are needed to comply, at his/her own expense. Truck will not be leased on until it receives passing inspection in Fort Wayne.

Circle Transportation will Reimburse driver for 1/2 of the cost of fuel to bobtail to Fort Wayne for orientation, paid on the first settlement. No receipts are needed, this will be figured from zip code to zip code, based on 7 mpg and whatever the national average of fuel cost is for the week.

Orientations are held on Mondays and Wednesdays and vary in length. Normally orientations are only 1 day but can be stretched to 2 if issues arise or if there are more than 2 drivers in 1 session. Load will be provided from orientation.

Orientation Documents

- Vaild Class A CDL (from state of residence w/ current address)
- Social Security Card
- Long form DOT physical and Card (must have at least 3 months remaining until expiration)
- Voided check for direct deposit
- TWIC card and passport (if applicable)
- Copy of current tractor title (both front/back sides)
- Copy of lease & power of attorney (if power unit is leased)
- Current base plate and registration (if not electing to purchase through Circle)
- Current collision and bobtail insurance policies (if not electing to purchase through Circle)
- Receipt for payment of Federal Highway Use Tax form 2290, clearly marked paid for current year-the fiscal year runs from July 1 through June 30th

Broker Carriers

If you are an outside Carrier and prefer to run under your own MC #, the information in this presentation does not apply to you. Circle Logistics, our sister company, can broker you freight when something is available but we do not lease on outside Carriers and run them as if they are part of our fleet.
